If the Candidate holds both FSD and EAP, send only the F-59 (EAP) to Croker at registration. Cancellations received less than two weeks prior to the scheduled course date will be subject to a 20% administrative charge. Registrants who do not cancel or attend forfeit the entire fee. The fee may not be applied to the next scheduled class. Course substitutions are permitted prior to the first day of class.
